Four years of post-*Master's* research was completed within an external doctoral program based upon the Oxford model of interrogatory research response. This program was started by a retired, Michigan State Bar - licensed attorney who became interested in and studied natural medicine on the English model through a doctorate. He was widely published by *Simon & Schuster* and others. The program he created was approved by the state Board of Education 1972 - 1976 but did not achieve regional accreditation. It was an early precursor to distance learning universities such as *Nova University and Walden University*; as well as on-line education programs such as *University of Phoenix*. Doctoral transcripts available upon request. The study was directed toward a critical philosophical examination of the relationship between Carl Jung's Analytical Psychology and classical metaphysical inquiry. The purpose of the dissertation was to reconcile differences between Jung's espoused anti metaphysical position and legitimate metaphysical investigation. Questions concerning: the

philosophy of science, empirical vs. phenomenological investigation and subjectivity - objectivity were cast in an analytical perspective to resolve ambiguities in Jung's Kantian orientation.
